7.	Deputy Director, Directorate of Industries	Member Secretary

The ANInT will serve as the nodal team driving the Andaman & Nicobar Innovation & Start-Up Policy.

**The Innovation Team shall perform the following functions :**

- The Andaman & Nicobar Innovation Team (ANInT) will review all monetary benefit application forms of the Start-Ups and will undertake due diligence of the requisite documents. Post review, ANInT will share the documents with the Start-up Council within two weeks. ANInT may schedule a call or a meeting with the applicant start-up, if required.
- Monitor disbursement of fiscal incentives proposed in the policy.
- Create Specific Performance Indicators (SPIs) for monitoring the policy objectives.

- d) Build a dedicated online portal for the Andaman & Nicobar Innovation & Start-Up Initiative. The portal will track the progress on the policy in real time, ensuring transparency and accountability in target monitoring and reporting.
- e) Periodically review the implementation process and report the progress to A & N Start-Up Council.
- f) Revisit the policy document from time to time to review and suggest recommendations to Start-Up Council to realign it as per the changing requirements of the eco-system.
- g) The ANInT will review each Start-Up every 04 months and shall submit a report to Start-Up Council.
