I am directed to refer to your letter no. 16/4/2011-SS dated 30th Jan, 2012 on the subject cited above and to inform you about the status at our end:-

1. The Oil spill Disaster Contingency Plan for Andaman and Nicobar Islands is under finalization. The draft plan has been prepared by the pollution Control committee and examined in consultation with Coast Guard Region (Andaman Nicobar). The final draft will be sent to Coast Guard for approval shortly.
2. Further, a State Level Monitoring Committee under the chairmanship of Chief Secretary, A&N Administration and a working Group under the Chairmanship of Director, Disaster Management have been constituted to handle issues relating to oil spills including preparedness to handle oil spill related emergencies.
