#### **NOTIFICATION**

No.5-5/EC/A&N/2015: Whereas, the proposals for delimitation for Gram Panchayat, Panchayat Samiti and Zilla Parishad constituencies in South Andman District and Nicobar District (Campbell Bay Block) were published in the Official Gazette vide Notification No. 5-5/EC/A&N/2015 dated 14th May, 2015 inviting suggestions and objections by 25th May, 2015 in compliance with rule 7 (1) & (2) of the Andaman and Nicobar Islands (Panchayat) (Preparation of Electoral Rolls and Conduct of Elections) Rules, 1995,

And whereas, suggestions and objections received before the specified date were considered by the Election Commission appointed under section 185 of the Andaman and Nicobar Islands (Panchayats) Regulation, 1994;

And whereas opportunity of a public hearing was afforded to all persons who made suggestions and objections including representatives of political parties in Ferrargunj Block in an open meeting at 3.00 p.m on 29.05.2015 at the Ferrargunj Panchayat Samiti Hall;

Now, therefore, in pursuance of section 11(4), section 107(2) and section 145 (2) of the Andaman and Nicobar Islands (Panchayat) Regulation, 1994 read with rule 7 (2) (d) of the Andaman and Nicobar Islands (Panchayat) (Preparation of Electoral Rolls and Conduct of Elections) Rules, 1995, the Election Commission for the Union Territory of the Andaman & Nicobar Islands, after considering all the suggestions and objections received and taken up in the aforementioned public hearing, hereby determines the delimitation of the Gram Panchayat, Panchayat Samiti and Zilla Parishad constituencies in South Andman District and Nicobar District (Campbell Bay Block) as detailed in Annex-II, appended to this notification and publishes the same in the Official Gazette.

Detailed maps showing the extent of each constituency of each Gram Panchayat are included as Annex-III.

The suggestions and objections received in response to the Election Commission's proposals for delimitation of each constituency of Gram Panchayats, Panchayat Samitis and Zilla Parishad in South Andaman District and Nicobar District (Campbell Bay Block) have been summarized and the Election Commission's order thereon is enclosed as Annex-I.

Final Order of Election Commission on delimitation of Gram Panchayat, Panchayat Samiti and Zilla Parishad constituencies in the South Andaman District and Nicobar District (Campbell Block) for the forthcoming election

Draft delimitation proposals in respect of Gram Panchayat, Panchayat Samiti and Zilla Parishad constituencies in the South Andaman District and Nicobar District (Campbell Bay Block) were notified on 14.05.2015 by the Election Commission in exercise of powers under section 11 (3) & 11 (4), section 107 and section 145 of the Andaman and Nicobar Islands (Panchayat) Regulation, 1994 read with rule 7(1) & (2) of the Andaman and Nicobar Islands (Panchayat) (Preparation of Electoral Rolls and Conduct of Elections) Rules, 1995. Suggestions and objections were invited upto 25.05.2015.

In all, twenty one objections and suggestions from various persons and political parties were received by the due date. All the objections and suggestions received have been duly considered by the Election Commission.

Three suggestions/objections were received from Little Andaman Block, which were mainly for creation of a new Gram Panchayat. The objections have been considered in light of the provisions of the Andaman and Nicobar Islands (Panchayat) Regulation, 1994 and the rules made thereunder. The powers for creation of a new Gram Panchayat vest with the Lt. Governor (Administrator). These objections, therefore, do not fall in the purview of the Election Commission, hence, the objections could not be considered by the Election Commission.

Only one suggestion/objection from Campbell Bay Block was received. Since the objector, i.e. Pradhan, Gram Panchayat Govind Nagar, was available in Port Blair, she was given a hearing in Port Blair. The objector conveyed that the Gram Sabha of Govind Nagar Gram Panchayat had resolved that it does not want its ward No. 6 to be merged with Campbell Bay Gram Panchayat under any circumstances, and, if this is done, it would be a great disservice to them. The Pradhan, Campbell Bay Gram Panchayat, also then came to Port Blair. He has agreed to the retention of Ward No. 6 in Govind Nagar Gram Panchayat but requested that the number of wards in Campbell Bay Gram Panchayat be reduced from 11 to 10 as the wards are already too small. The Commission finds this request to be reasonable as the reduction in number is only to rationalize the wards with the population more equalitably. Since there is no change in the revenue villages proposed in the arrangement and in pursuance of the detailed discussions with the Pradhan, Campbell Bay Gram Panchayat, and Pradhan, Govind Nagar Gram Panchayat and other representatives from both the Gram Panchayats, the suggestion has been accepted by the Election Commission in the larger interest of the residents. The changes in the textual boundaries and maps of both the Gram Panchayats have been incorporated. The Deputy Commissioner, Nicobar District, is being asked to reduce the number of seats of Campbell Bay Gram Panchayat on the request of the residents of Campbell Bay Gram Panchayat.

For Ferrargunj Block, seventeen persons filed their objections relating to delimitation of Gram Panchayat, Panchayat Samiti and Zilla Parishad constituencies in Ferrargunj Block. These objections/suggestions are summarised below in five broad categories:-

(i) Six objectors demanded that the Muslim Basti under Mithakhari Gram Panchayat should be brought under Tushnabad Gram Panchayat because of its closer proximity to Tushnabad Gram Panchayat. One objector demanded

that Kurmadera, Mahuadera, Sunset Bay and Balughat revenue villages be relocated from the newly created Collinpur Gram Panchayat to Tushnabad Gram Panchayat.

- (ii) Two objectors demanded the distribution of voters amongst different constituencies of Gram Panchayats to make them more equitable and rationalized.
- (iii) One objector demanded that door-to-door survey may be done to prepare new electoral rolls.
- (iv) Two objectors demanded creation of an additional Panchayat Samiti in Ferrargunj Block because this block has a much larger number of Gram Panchayats, i.e., 19, as compared to other blocks in the Islands. Moreover, the population of this Panchayat Samiti is also much higher.
- (v) Six objectors demanded that allocation of Zilla Parishad constituencies under the Ferrargunj Block be rationalized by having a more equitable clubbing of Gram Panchayats in determining the Zilla Parishad constituencies.

The Commission heard all the objectors present in the public meeting held at Panchayat Samiti Hall, Ferrargunj on 29.05.2015 and after due consideration and keeping in view the provisions of Regulation/rules governing the delimitation, the Commission has decided as under:

The shifting of Muslim Basti from Mithakhari Gram Panchayat to Tushnabad Gram Panchayat could not be considered as the Lt. Governor (Administrator) vide Notification No.63/2015 dated 27.04.2015 has already specified the composition of Tushnabad Gram Panchayat on the basis of the revenue villages of Hobdyapur and Tushnabad. The Muslim Basti revenue village continues to be part of Mithakhari Village (Gram Panchayat). This incidentally was also desired by the residents of Muslim Basti who had come for the public hearing in large numbers to emphasize that they wished to remain with Mithakhari Gram Panchayat. The Election Commission felt that there was therefore no ground to consider the shifting of Muslim Basti from Mithakhari Gram Panchayat. Similarly shifting Kurmadera, Mahuadera, Sunset Bay and Balughat revenue villages from the newly created Collinpur Gram Panchayat to Tushnabad Gram Panchayat did not have any valid basis. The Commission, therefore, did not accept the suggestion.

As regards the suggestion for distribution of population among different wards of Gram Panchayats, the Commission has agreed to the suggestions and incorporated the changes to the extent possible.

Regarding the suggestion of door-to-door survey for preparation of electoral rolls for Panchayats, it was explained to the objector that the Commission takes the Parliamentary electoral roll as the mother roll for Panchayat elections and the same would be published for inviting suggestions and objections. The objectors could file their objections/suggestions whenever the schedule for revision of electoral rolls is published.

The Commission also heard the objectors for creation of additional Panchayat Samiti for Ferrargunj Block and redistribution of Zilla Parishad constituencies. The Commission has observed that there is an overwhelming demand for an additional Panchayat Samiti for Ferrargunj. Considering this, the Commission would refer the matter to the A&N Administration for taking a view in this regard.

Regarding the suggestions of allocation of Zilla Parishad constituencies in Ferrargunj Block, the Commission heard the objectors and after discussion agreed to the suggestions to the extent that Kanyapuram Gram Panchayat be clubbed with Bindraban Gram Panchayat for the Zilla Parishad Member constituency. The public were satisfied with this arrangement and no further changes were required.

After due consideration of the suggestions, the Election Commission modifies its notification of draft proposals for the delimitation of Gram Panchayat, Panchayat Samiti and Zilla Parishad constituencies and hereby orders the final delimitation of Gram Panchayat, Panchayat Samiti and Zilla Parishad constituencies under South Andaman District and Nicobar District (Campbell Bay Block) as detailed in Annex-II.
