

## RECRUITMENT NOTICE

### RECRUITMENT FOR THE POST OF POLICE CONSTABLE (EXECUTIVE) IN ANDAMAN AND NICOBAR POLICE

Applications are invited from eligible candidates for the post of Police Constable (Executive) in Andaman and Nicobar Police. The number of post, scale of pay and eligibility conditions are given below: -

#### 1. Name of Post – Police Constable (Executive)

- i) **No. of Vacancies:** 37 (20 vacancies for General, 14 Vacancies for OBC and 3 vacancies are reserved for ST candidates of A & N Islands)

Note: Vacancies may increase or decrease depending upon the requirements at the time of final selection.

- ii) **Pay Band + Grade Pay:** PB-1 Rs.5200-20200 + Grade Pay Rs.2000/-

- iii) **Eligibility Conditions:**

a) Age limit (As on 15/04/2013)	i) 18-25 years for male (upper age relaxable by 3 years for OBC and 5 years for ST candidates). ii) 18-30 years for female (upper age relaxable by 3 years for OBC and 5 years for ST candidates).

#### 2. Physical Endurance Test

The candidates who qualify after physical measurement shall undergo a physical endurance test as per the following standards.

Male	Female
a) 1 mile race (to be completed in 7 minutes)	a) 0.5 mile race to be completed in 5 minutes.
b) 4 feet High Jump ( 3 chances will be given)	b) 3 feet High Jump (3 chances will be given).
c) 12 feet Long Jump (3 chances will be given).	c) 8 feet Long Jump (3 chances will be given).

Note: - Candidates have to qualify in each event of Physical Endurance Test, otherwise they will be eliminated at that stage itself.

### **3. WRITTEN EXAMINATION**

The candidates who qualify in Physical Measurement and Physical Endurance Test will undergo a written test. The paper will be set both in English and Hindi. Candidates will have the option of answering in either language except for the portion of language paper, which will contain questions on Hindi and English both.

The question papers(s) will cover general knowledge, reasoning, simple arithmetic, test of language and essay and will carry 85 marks.

### **4. INTERVIEW**

The candidates who qualify in the written test will be subjected to an interview of 10 marks by a selection board. During the interview the overall personality, aptitude, attitude and general awareness of the candidates will be judged.

Apart from this, additional marks up to a maximum of 5 marks shall be awarded for achievements in Sports and NCC as follows:-

a) NCC 'C' Certificate	:	2 marks
b) NCC 'B' Certificate	:	1 mark
c) Gold medal at National level in sports	:	5 marks
d) Silver medal at National level in sports	:	4.5 marks
e) Bronze medal at National level in sports	:	4 marks
f) Gold medal at State level in sports	:	3.5 marks
g) Silver medal at State level in sports	:	3 marks
h) Bronze medal at State level in sports	:	2.5 marks

Candidates should bring all their original certificates regarding their achievements in Sports and NCC at the time of interview.

On the basis of vacancies at the relevant time a final list of successful candidates shall be prepared on the basis of the marks obtained in the written paper, NCC/Sports marks and interview.

### **5. Medical Examination**

Successful candidates shall be subjected to medical examination as given below:

- i) Minimum distant vision should be 6/6 and 6/9 of two eyes without correction i.e. without wearing of glasses. The candidate should not be Colour Blind.
- ii) The candidate must not have knock-knees, flat feet, varicose veins, squint eyes, bow legs, inability to close either eye, inability to flex the fingers properly or any other obvious deformities.
- iii) The candidate must be in good mental and physical health and free from any physical defects likely to interfere with the efficient performance of police duties.



## 6. HOW TO APPLY

- i) Candidates may submit their application on a plain paper in the format given below along with the self attested copies of certificates of age proof (10<sup>th</sup> class certificate), ST/OBC category and education qualification with three passport size photographs (one should be affixed in the space given in the application form and other two should be attached along with application form) to Dy. Superintendent of Police (Estt), Police Head Quarter, Atlanta Point, Port Blair on any working day with effect from 25/03/2013 to 15/04/2013.

The submission of any forged document shall entail the registration of a criminal case.

## 7. Closing Date

Application form should be deposited to the Dy. Superintendent of Police (Estt), Atlanta Point, Port Blair latest by 1700 hrs on 15/04/2013.

## 8. Instructions in General

- i) After scrutiny and acceptance of the application forms, each applicant will be issued an Admit card, which will be required at all, stages of the recruitment. The Admit card should be collected by the candidate from 24/04/2013 to 26/04/2013 from Recruitment Cell, Police Head Quarter, Atlanta Point, Port Blair
- ii) Original documents (Educational qualifications, ST/OBC category, age proof and sports/NCC certificates) will be checked at the time of 'Interview'. The candidates, therefore, should bring these original documents/ certificates only at the time of interview.
- iii) Applications found incomplete in any form are liable to be rejected and no further correspondence will be entertained in this regard. No Admit Card will be issued in case the application is rejected.
- iv) Candidates failing at any stage will be eliminated at that stage itself.
- v) The candidates shall prepare for the physical endurance test and participate at their own risk. The A&N Police will not be liable for any damages in the event of any injury or any casualty suffered by a candidate during the test.
- vi) The candidates who are not satisfied with the decision of the Recruitment Board concerning their Physical Measurements only may prefer appeal in writing in the prescribed format to the appellate authority on the same day.
- vii) The date, time and venue of Physical Measurement and Physical Endurance Test shall be communicated in due course through local newspapers, All India Radio etc.
- viii) No TA or DA will be paid to the candidates for attending the selection process or Interview.
