Note : No candidate shall be allowed to take more than one subject of the group (i) Agriculture, Agriculture Engineering and Veterinary Science (ii) Chemistry and Chemical Engineering (iii) Computer application. Computer Science and Computer Engineering (iv) Electrical Engineering and Electronic (v) Mathematics and Statistics. Candidates must pass physical endurance test of 25 Kms. by walk for male and 16 Kms. for female to be completed in 4 hours. The selected candidates will have to successfully complete 18 months Forest Rangers training at any one of the Training College at Mainland.
