

RECRUITMENT NOTICE FOR THE POST OF CONSTABLE (EXECUTIVE) IN A & N POLICE

Applications are invited from eligible candidates for the following post in Andaman & Nicobar Police. The number of Post, scale of pay and eligibility conditions are given below:-

Note: - Vacancies may increase/decrease depending upon the position at the time of final selection.

1. Name of Post - Police Constable (Executive)

- (i). **NO. OF VACANCIES:** 103 (48 vacancies for General, 40 vacancies for OBC and 15 vacancies are reserved for ST candidates of A&N Islands).
- (ii). **Pay Band + Grade Pay** - PB-1 Rs.5200 - 20200 + GP Rs.2000/-

2. PHYSICAL ENDURANCE TEST

The candidates who qualify physical measurement shall undergo physical endurance test as per the following standards.

Male	Female
a) 01 mile race (to be completed in 7 minutes)	a) 0.5 mile race (to be completed in 5 minutes).
b) 04 feet High Jump (3 chances will be given).	b) 3 feet High Jump (3 chances will be given).
c) 12 feet Long Jump (3 chances will be given).	c) 8 feet Long Jump (3 chances will be given).

Note: - Candidates have to qualify in each event of physical Endurance Test, otherwise they will be eliminated at that stage only.

3. WRITTEN EXAMINATION

The candidates who qualify in Physical Measurement and Physical Endurance Test will take a written test as per the following scheme. The paper will be set both in English and Hindi. Candidates will have the option of answering in either language except for the portion of language paper, which will contain questions on Hindi and English both.

Constable (Executive)	Paper-I (85 marks)	The question paper will cover general knowledge, reasoning, simple arithmetic, test of language and essay.

4. INTERVIEW

The candidates who qualify in the written test will be subjected to an interview by the selection board. The interview will be for 10 marks. During the interview the overall personality, aptitude, attitude and general awareness of the candidates will be judged.

Apart from this, additional marks up to a maximum of 5 shall be awarded for achievements in Sports and NCC as follows:-

Candidates should bring all their original certificates of achievements in Sports and NCC at the time of interview.

Final list of successful candidates shall be prepared on the basis of the marks obtained in the written paper, NCC/Sports marks and interview and on the basis of vacancies.

5. MEDICAL EXAMINATION

The successful candidates shall be subjected to medical examination as given below:

- i) Minimum distant vision should be 6/6 and 6/9 of two eyes without correction i.e. without wearing of glasses. The candidate should not have Colour Blindness.
- ii) The candidate must not have knock-knee, flat foot, varicose vein or squint eyes, bow legs, inability to close either eye, inability to flex the fingers properly or any other obvious deformities.
- iii) *The candidate must be in good mental and physical health and free from any physical defects likely to interfere with the efficient performance of police duties.*

6. HOW TO APPLY

- i) The Candidates may submit their application on a plain paper in the format given below along with the **self attested** copies of certificates of age proof, ST/OBC category and education qualification with **three passport size photographs** (one should be affixed in the space given in the application form and other two should be attached along with application form) to any Police Station of A&N Islands/Welfare Centre, Police Lines, Port Blair/Police Head Quarter, Atlanta Point, Port Blair on any working day with effect from 10/10/2009 to 09/11/2009.
- ii) Acknowledgment receipt will be issued on depositing the form which should be retained by the applicant.
- iii) The application submitted to any officers other than those authorized as above mentioned, will not be accepted and no representation in this regard will be entertained. One candidate can submit only one application. If any candidate submits more than one application, his candidature will be liable to be rejected.
- iv) There will be 7 (seven) centres for Physical Measurement/Physical Endurance Test. The candidates have to submit their option for any one of them. The option of centre for PM/PET will not be changed in any circumstances.

7. CLOSING DATE

Application form should be deposited in the above designated offices latest by 1700 Hrs on 09/11/2009.

8. INSTRUCTIONS IN GENERAL

- i) After scrutiny and acceptance of the application forms, each applicant will be issued an **Admit card**, which will be required for all stages of the recruitment. The Admit cards should be collected by the candidate from **27/11/2009 to 03/12/2009** from the respective Police Station.
- ii) Benefit of ST/OBC category would be given only to those Candidates who belong to the ST/OBC category as notified by Andaman and Nicobar Administration.
- iii) Original documents (Educational qualification, age proof, sports/NCC and ST/OBC category) will be checked at the time of '**interview**'. The candidates, therefore, should bring these original documents/certificates only at the time of interview.

Note:

- i) Applications found incomplete in any form are liable to be rejected and no further correspondence will be made in this regard. No Admit Card will be issued in case the application is rejected.
- ii) Candidates failing at any stage will be eliminated at that stage only.
- iii) The candidates shall prepare for the physical endurance test and participate at their own risk. A & N Police will not be liable for any damages in the event of any injury or other casualty suffered by a candidate during the test.
- iv) The candidates who are not satisfied with the decision of the Recruitment Board about their Physical Measurements may prefer appeal in writing in the prescribed format to the appellate authority on the same day.
- v) The date, time and venue of Physical measurement, Physical Endurance test, written test and Interview shall be communicated in due course through local newspapers, All India Radio etc.
- vi) No TA or DA will be paid to the candidates for attending the selection Process/Interview.


