4. PHYSICAL ENDURANCE TEST

The candidates who qualify physical measurement shall undergo physical endurance test as per the following standards, for both the categories of posts.

Note: - Candidates have to qualify in each event of Physical Endurance Test, otherwise they will be eliminated at that stage only.

5. WRITTEN EXAMINATION

The candidates who qualify in Physical Measurement and Physical Endurance Test shall be put through the written examination. The scheme of papers in the written examination for each post is as given below.

Syllabus for written papers

Paper-A: In this paper, a candidate's general knowledge on current affairs, important happenings around him in the country/abroad, Indian history, polity, geography, scientific research, simple mathematics and reasoning will be tested, as is expected of any educated person.

Paper-B: In this paper a candidate's understanding of English language, its correct usage and writing ability would be tested. Questions on grammar, usage, short essay, letter writing, précis, paragraph/report writing and translation would be included.

Paper-C: In this paper, a candidate's knowledge, as a science graduate, on simple mathematics, physics, electronics, computers and other science subjects will be tested, with questions mainly of high school standard.

Paper-D: In this paper, a candidate's knowledge in Basic Electronics, Digital Electronics, Power Electronics, Communication Systems, Radio Waves, Antenna, basic computer, A.C theory and Microwave Engineering will be tested.

Paper-E: In this paper a candidate's understanding of English and Hindi languages, their correct usage, simple mathematics, reasoning and general knowledge will be tested.

6. INTERVIEW

The candidates who qualify in the written test will be subjected to an interview by the selection board. The interview will be of 25 marks for the post of Radio Operator/Cipher Operator and 15 marks for the post of Radio Technician. During the interview the overall personality, aptitude, attitude and general awareness of the candidates will be judged.

Apart from this, additional marks up to a maximum of 5 shall be awarded for achievements in Sports and NCC as follows:-

Candidates should bring all their original certificates of achievements in Sports and NCC at the time of interview.

Final list of successful candidates shall be prepared separately for each post on the basis of the marks obtained in the written paper(s), NCC/Sports marks and interview out of 230 for the post of Radio Operator/Cipher Operator and out of 150 for the post of Radio Technician on the basis of vacancies and the preference for posts given by the candidates.

7. MEDICAL EXAMINATION

The successful candidates shall be subjected to medical examination as given below:

- i) Minimum distant vision should be 6/6 and 6/9 of two eyes without correction i.e. without wearing of glasses. The candidate should not have Colour Blindness.
- ii) The candidate must not have knock-knee, flat foot, varicose vein or squint eyes, bow legs, inability to close either eye, inability to flex the fingers properly or any other obvious deformities.
- iii) The candidate must be in good mental and physical health and free from any physical defects likely to interfere with the efficient performance of police duties.

8. HOW TO APPLY

- i) A candidate needs to submit only one application even when applying for all posts. A Candidate will indicate in the application whether he is applying for one or more post. Those applying for more than one post will also have to indicate the preferences in the posts applied.
- ii) One candidate can submit only one application (even if applying for more than one post). If any candidate submit more than one application, his candidature will be liable to be rejected.
- iii) The Candidates may submit their application on a plain paper in the format given below along with the **self attested** copies of certificates of age proof, ST/OBC category, education qualification and copy of

technical qualification, **with three passport size photographs** (one should be affixed in the space given in the application form and other two should be attached along with application form) to **Dy. Superintendent of Police (HQ), Atlanta Point, Port Blair from 19/10/2009 to 18/11/2009.**

9. CLOSING DATE

Application form should be deposited in the above designated office latest **by 1700 Hrs on 18/11/2009.**

10. INSTRUCTIONS IN GENERAL

- i) After scrutiny and acceptance of the application forms, each applicant will be issued an **Admit card**, which will be required for all stages of the recruitment. The Admit cards should be collected by the candidate between the dates **23/11/2009 to 26/11/2009** from Recruitment Cell, Police Head Quarter, Atlanta Point, Port Blair
- ii) Original documents (Educational qualifications, Technical qualification, age proof, sports/NCC and ST/OBC category) will be checked at the time of **'interview'**. The candidates, therefore, should bring these original documents/ certificates only at the time of interview.

Note:

- (i) Applications found incomplete in any form are liable to be rejected and no further correspondence will be made in this regard. No Admit Card will be issued in rejection cases.
- (ii) Candidates failing at any stage will be eliminated at that stage only.
- (iii) The candidates shall prepare for the physical endurance test and participate at their own risk. A & N Police will not be liable for any damages in the event of any injury or other casualty suffered by a candidate during the test.
- (iv) The candidates who are not satisfied with the decision of the Recruitment Board about their Physical Measurements may prefer appeal in writing in the prescribed format to the appellate authority on the same day.
- (v) The date, time and venue of Physical measurement, Physical Endurance test, written test and Interview shall be communicated in due course through local newspapers, All India Radio etc.
