The Andaman Public Works Department(APWD) under the Andaman and Nicobar Administration is inviting applications from amongst the eligible Local Scheduled Tribe candidates covered under the category of "Tribes" as specified under constitutions (A&N Islands) Scheduled Tribe Order 1959 and Local other Backward Class candidates covered under the category of 'OBC' as specified in the Gazette Notification No.343/2005/F.No. 8-3/2003-TW dated 16-12-2005 and No. 75/2006/F.No.8-3/2003-TW dt. 19-04-2006.

1. (i) Category of Post - **DRAUGHTSMAN GRADE-III(E&M)**

- (iii) Scale of Pay - PB-1 Rs.5200-20200/- + GP 2400/- (Revised Scale)
- (iv) Classification of the Post - Group 'C' (Non Ministerial, Non Gazetted)
- (v) Qualification required - (a) Matriculation OR its equivalent
(b) 2(two) years certificate course including practical training of six(6) months in Draughtsman in (Electrical & Mechanical) or degree in Electrical and Mechanical Engineering or Diploma in Electrical and Mechanical Engineering from a recognized Institution.
- (vi) Nature of Vacancy - Temporary, but likely to continue.
- (vii) Age Limit * - 18-33 years for Male candidate
18-38 years for Female candidate
(Age relaxable for Govt. servants in accordance with the instructions or orders issued by the Central Government from time to time).
