I am directed to say that the 8 (Eight) posts of Sub – Inspector (Master) and 14 (Fourteen) posts of Sub – Inspector (Engine Driver) in the pay Band PB-1 Rs. 9300-34800 + Grade Pay Rs. 4200 are proposed to be filled up on Deputation/Re-employment from amongst the eligible Officers of Central / State Govt./ UT Administration / Autonomous Organization / Public Sector Undertakings.

Such officials will be given deputation term up to the date on which they are due for release from the Naval/Coast Guard and thereafter they may continue on re-employment. (Re-Employment up to the age of Superannuation with reference to Civil post)

b) Possessing First Class Engine driver's Certificate of Competency under the ISV Act, 1917 (1 of 1917) and qualify departmental trade test.

Technical Qualification required for appointment on Re-employment:-

Serving Naval/Coast Guard Personnel/ex-Naval/Coast Guard personnel at least in the rank of Petty Officers possessing minimum 15 years experience in Ship's Propulsion/ Machinery. Such officials will be given deputation term upto the date on which they are due for release from the Naval/Coast Guard and thereafter they may continue on re-employment. (Re-Employment up to the age of Superannuation with reference to Civil post)

The selected Naval/Coast Guard Personnel or Ex-Naval/ Coast Guard Personnel should obtain First Class Engine Driver's Certificate of Competency under the ISV Act, 1917(1 of 1917) within 3 (three) years from the date of his appointment failing which his service shall be terminated.

Terms & conditions of Appointment on deputation/Re-Employment

- In addition to pay, the selected person will be entitled to DA admissible to Government servants at the Central Government Rates.

Call letters will be issued to the eligible candidates for deputation to appear for qualifying departmental trade test. The serving and ex-naval / Coast Guard Personnel have to appear for interview before the selection board. Date, time and Venue will be intimated to the candidates for trade test and interview and no TA/DA will be paid to them. The selected candidates have to work anywhere in Andaman & Nicobar Islands.
