
1. (i) **Number of vacancies** for the post of PC Driver (Exe)- 5 Posts (10%) are reserved for Departmental candidates as per the notified RR.
1. (iii) **Eligibility for Departmental Candidates:** -
  - (a) Age Limit (as on 03/01/2011)- 18-30 years for Police Constable of A & N Police
  - (b) Police Constables of various units of A & N Police having valid LMV License.

#### Written test

5. For the post of Constable Driver (Fire Service), there is only Trade test & Interview and no written examination.

#### **7. General Instructions :-**

### 4. Trade Test

The candidates who qualify in the physical endurance test will be required to qualify in the trade test of 100 marks, which will involve:

Only those candidates who obtain 50% or more marks will be considered qualified in the trade test.

### 5. Written Examination

Candidates who qualify in the trade test shall be put through a written examination of 70 marks. The question paper will cover General Knowledge, Simple Arithmetic and English.

### 6. Interview/Personality Test

The candidates who qualify in the written test will have to appear for an Interview/personality test, which will of 30 marks. The final list of the selected candidates, in order of merit, will be prepared by adding the scores obtained by the candidates in the trade test, written test and the personality test.

### 7. General Instructions :

- i) A candidate needs to submit only one application even when applying for both posts. A candidate will indicate in the application whether he is applying for both the posts and one post. Those who are applying for both posts, will also have to indicate the preferences in the post applied.
- ii) One candidate can submit only one application (even if applying for both posts). If any candidate submit more than one application, his candidature will liable to be cancelled.
- iii) Self attested copy of ST/OBC certificate issued by competent authority and notified by Andaman & Nicobar Administration.
- iv) Original documents (Educational Qualifications, age proof, ST/OBC Category, and driving license) will be checked at the time of 'Interview'. The candidate, therefore, should bring these original documents/ certificates only at the time of interview.
- v) Applications which are incomplete and applications received after the due date will not be entertained under any circumstances and no claims in this regard shall be entertained.
- vi) Date and Venue of the physical measurement, endurance test, trade test, written test and interview will be intimated in due course.
- vii) Candidates, who do not qualify in the Physical Measurement, will be rejected. In case of any doubt in the physical measurement, the candidate may appeal in writing to the appellate authority.
- viii) The candidates shall participate in physical endurance and trade tests at their own risk. A & N Police will not be liable for any damages in the event of any injury or other casualty suffered by a candidate during the test.
- ix) The final list of the selected candidates will be published and displayed on the Notice Boards at Police Head Quarter, SI District Car-Nicobar Office, Police lines and other selected places besides publication in local newspaper.
- x) Each selected candidate will be subjected to a medical examination and verification of character and antecedents, before issuance offer of appointment in the A & N Police.
- xi) No TA or DA will be paid to the candidates for attending the selection process/ interview.
- xii) Selected candidate will have to undergo basic physical training anywhere in India.
- xiii) Selected candidates will be posted anywhere in A & N Islands.


