- a) (i) Officials holding analogous posts on regular basis in the parent cadre/ department

OR

- (ii) With 5(Five) years service in the grade rendered after appointment thereto on a regular basis in the Pay Band-1:Rs5200-20200+2400(GP) in the parent cadre/ department

AND

- (b) Possessing a Second Class Engine Driver's Certificate of competency under the ISV Act 1917 (1 of 1917) and qualify departmental trade test.
