#### PRESS NOTE

In accordance with the provisions of sub-section(i) of section 29 of the RTE Act-2009, the National Council of Teacher Education(NCTE) had vide notification dated 23<sup>rd</sup> August, 2010 laid down the minimum qualification for a person to be eligible for appointment of teacher in class I to VIII. It had been inter-alia provided that one of the essential qualifications for a person to be eligible for appointment as a teacher any of the schools referred to in clause(n) of section 2 of RTE Act is that he/she should pass the Teacher Eligibility Test(TET) which will be conducted by the appropriate Government in accordance with the Guidelines framed by the NCTE.

The Ministry of Human Resource Development (MHRD), Govt. of India has entrusted the responsibility of conducting the Central Teacher Eligibility Test (CTET) to Central Board of Secondary Education(CBSE), New Delhi and the CTET examination will be held on 26.06.2011. The CBSE conducted CTET shall apply to all schools under the Administrative control of UT of Andaman and Nicobar Islands.

In pursuant to above, it is for information of all concerned that CTET shall be conducted in A & N Islands by the CBSE as per the schedule given below:-

<u>Pattern of Examination</u>: The CTET examination will be of objective type multiple choice questions (MCQ's). There will be no negative marking and there will be two papers of CTET.

- i) Paper-I will be for a person who intends to be a teacher for classes I to V.
- ii) Paper-II will be for a person who intends to be a teacher for classes VI to VIII.
- iii) A person who intends to be a teacher for both levels (classes I to V and classes VI to VIII) will have to appear both the paper I and paper II)

#### The Cost of CTET information Bulletin and application form

- i) For General /OBC candidates Rs. 500/-.
- ii) For SC/ST/Differently abled candidates Rs. 250/-.

Candidates are required to take print out of the computer generated application form/confirmation page after successful submission of data. Applications can be submitted through online with effect from 08.04.2011 and the fee can be remitted through credit card/debit card or through demand draft in favour of the Secretary, CBSE, New Delhi drawn in any nationalized bank payable at Delhi. The application Form/confirmation page complete in all respect should be sent by Registered post/speed post to the "The Asst.
