- ii) The appointment of coaches in the A&N SSC will be purely on contract basis for a period of 06 months.
- iii) The coaches recruited for the A&N SSC will be posted in A&N SSC at Netaji Stadium, Port Blair.
- iv) No request to transfer to any other particular place during the contract period would be entertained.
- v) The discretion to post the selected coach and subsequent transfer will solely rest with the President A&N SSC.
- vi) The Coaches recruited for A&N SSC will perform the duties as and when assigned by the General Secretary SSC.
- vii) During the period of engagement the coach will be paid a consolidated remuneration of Rs 16,000/- Per month for working on 6 days a week (Sunday being a Holiday).
- viii) The coach selected will be entitled to avail Leave as follows:
 - Earn Leave as admissible to Central Govt. Servant governed by Central Civil Service Leave Rule 1972.
 - b. Half pay leave / commuted leave as admissible to Temporary Govt Servant under Central Civil Service Leave Rule 1972.
- ix) The coach selected may required to proceed outside the place of posting on official duty in such case he/she will be entitled to TA/DA as admissible under the rules to non-official members of A&N SSC.
- x) He/She will not be entitled to any other facilities like reimbursement of Medical Expense, Leave travel concession etc.
- xi) The engagement with the SSC can be terminated after giving one month notice from either side.
- xii) During the period of engagement, the works / performance would be under observation. If the performance is not as per requirement then the agreement can be terminated.
- xiii) He/she may be ask to perform specific acts and duties and shall have to discharge them with full satisfaction of the supervising officer.
- xiv) No request for any kind of transfer would be entertained whatsoever. However, depending upon the requirements the A&N SSC can transfer the coaches within the period of engagement to any other place of posting within A&N Islands.
