1. The State Project Director, Sarva Shiksha Abhiyan, UT Mission Authority, Andaman & Nicobar Islands invites applications against the following vacancies from the eligible candidates in the prescribed form for the post of SSCT/CRP/BRP/BRP(CWSN) and Part Time Instructors purely on **contract basis** for the academic session 2012-13.

2. **EDUCATIONAL QUALIFICATION**

i. SSCT/BRP/CRP (No. of Posts: 272)

Essential Qualifications :

1. Bachelor's degree in the relevant subject or its equivalent from a recognized University.
2. Bachelor's Degree/Diploma in teaching/education or its equivalent OR JBT/D.El.Ed. or its equivalent from a recognized University/institution.
OR
Integrated degree BA/B.Sc.-B.Ed. in the relevant subject or its equivalent from a recognized University.
3. Knowledge of Hindi.
Desirable: (1) Master Degree / M. Phil. / Ph. D. in the relevant subject from a recognized University
(2) Preference shall be given to candidates who have cleared CTET.

Essential Qualifications :

1. Bachelor's degree in any stream or its equivalent from a recognized University.
2. Degree / Diploma/Certificate in the course of Art Edn./Physical & Health Edn./Work Edn. or its equivalent from a recognized University / institution.
3. Knowledge of Hindi.

Pay : Rs.7000/- per month (consolidated)

Age : up to 30 years as on 10-07-2012 + relaxation of age as per circular no. 45/1998-PW dated 19/09/2011 of A & N Administration

3. The SSCTs / BRPs/ CRPs who have served in the SSA till the closure of schools for Summer vacation-2012 will also have to submit the application to the office of SPO(SSA) along with attested copies of all the certificates / mark sheets , medium certificates, experience certificates and the proof for CTET clearance / appearance.
No fresh interview shall be conducted for the serving SSCTs / BRPs / CRPs but their re-engagement is subject to submission of application form to the office of SPO(SSA) and satisfactory performance during the year 2011-12 and as per the requirement / vacancies.
4. The application should be filled in the prescribed form, which can be obtained free of cost from any of the following Block Resource Centers.

5. The eligibility conditions (qualifications, experience and age etc) will be determined as on the closing date of receipt of offers i.e. **10-07-2012**.
6. A separate application form must be used for each stream, subject and each post. Duly filled in application in all respect (in block letters only) along with attested copies of the certificates of academic & professional qualifications and medium certificate are to be enclosed with the offer and should be submitted on any working day to the office of SPO(SSA) on or before 10/07/2012. Incomplete applications and those without proper supporting documents will be summarily rejected. **All the candidates except the serving candidates will have to produce all the original certificates including medium certificate at the time of walk-in-interview.**

7. (a). There shall be no interview for the serving SSCTs/ BRPs/ CRPs but their merit shall be decided as per the self marking Scheme to the total of 90.
 (b). Interview shall be conducted for 10 marks for all the fresh candidates besides the weightage of 90% for academic & experience.
 (c). Exemption from appearing for the interview shall not be extended to the serving SSCTs applying for the posts of BRP (CWSN) and Part Time Instructors. They will have to apply afresh for the new posts.
8. The valid applications shall be entertained under six categories as mentioned below:
- Serving SSCTs/ BRPs/ CRPs passed /cleared the CTET.
 - Fresh candidate passed /cleared the CTET.
 - Serving SSCTs/ BRPs/ CRPs without CTET.
 - Fresh candidate without CTET.
 - Fresh candidate for the post of BRP (CWSN).
 - Fresh candidate for Part Time Instructors, stream-wise i.e. Art Edn., Health & Phy.Edn. and Work Education.
9. The merit list of the above categories shall be prepared separately to decide the order of selection for engagement as per the option and requirement of the department. First preference will be given to the serving SSCTs/BRPs/ CRPs cleared / passed the CTET, Second preference for the fresh candidate cleared / passed the CTET, Third preference to the serving SSCTs / BRPs / CRPs without CTET and Fourth preference for fresh candidates without CTET (in case any vacancy remains). The place of posting shall be decided on the basis of merit and options given by the candidate and as per the requirement at BRC level. The merit of category (e) and (f) shall be derived separately as the vacancies are different in nature. If a candidate does not find place in the opted BRC as per the merit and requirement, he/she shall be considered, if merit permits, for the other BRCs as per the choice of the candidate and requirement.
10. The candidates for BRP (CWSN) and Part Time Instructors shall be selected from the respective merit list of concerned merit and their posting shall be as per the merit & options and requirement.
11. The candidates (serving / fresh) applying for the posts of SSCTs/CRPs/ BRPs will have to offer their order of choice / options for 07 BRCs as mentioned in application form for their posting in the event of selection.
12. As regards the candidates applying for the post of BRP (CWSN) and Part Time Instructors, the candidates will have to mention their order of choice / option for 09 BRCs as mentioned in application form for their engagement in the event of their selection.
13. The maximum age limit for eligibility shall be 30 years for male and female for all the posts. However, relaxation in the age limit shall be given to the serving / served candidates under SSA to the extent of period of service rendered under SSA and other Govt. institutions and shall be governed as per the circular no. 45/1998-PW dated 19th September, 2011 of A & N Administration, regarding relaxation of Upper-age limit.
14. (a). **Last date for submission of application at the office of SPO(SSA),Port Blair is 10/07/2012 (before 05:00 pm).**
 (b). The walk-in-interview for the vacancies of SSCT/BRP/CRP for the fresh candidates who have cleared / passed the CTET will be held on 15/07/2012 at 10:00 am at GSSS Mohanpura, Port Blair.
 (c). Walk in interview for the remaining posts/ vacancies of SSCT/CRP/BRP, if any, and for the posts of BRP(CWSN) and Part Time Instructors shall be conducted later and the date and venue will be intimated through print and electronic media in due course.
 (d). **No individual intimation/ call letter will be sent to any candidate.**
 (e). Any change in the date, time or venue of the walk-in interview will be published through print and electronic media. No individual intimation in respect of any changes will be sent to any candidate.
15. The candidate shall himself/herself do the self-marking in the application form (for 90 marks) as per the marking scheme, given below. Marks for engagement of **all the posts** shall be calculated as follows:
