AND  b) Possessing valid Heavy Vehicle Driving License.  Note: From the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 01.01.2006 (the date from which the revised pay structure based on 6th CPC recommendations has been extended) shall be deemed to be service rendered in the corresponding grade pay/pay scale extended based on the recommendations of the pay commission except where there has been merger of more than one pre-revised scale of pay in to one grade with a common grade pay/pay scale and where this benefit will extend only for the post (s) for which the grade pay/pay scale is the normal replacement grade without any up-gradation.

The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation; similarly deputationist shall not be eligible for consideration for appointment by promotion.

(Period of deputation, including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of Central Govt. shall ordinarily not exceeding 03 years. The maximum age limit for appointment on deputation shall be not exceeding 56 years as on the closing date of receipt of applications.

- This may widely be circulated among all police personnel of Central/State/ UTs/ CPMF /IRBn of other states/UTs.
- Application as per the proforma (Annexure-I) from willing and eligible officials be obtained and forwarded along with service particulars (Annexure-II) and Vigilance clearance so as to reach this office on or before 31st December, 2013.
- The candidature of the applicants will not be allowed to be withdrawn once selection conveyed.
- Deputation allowance and other allowances will be allowed as per rules.
