#### 6. PHYSICAL ENDURANCE TEST

The candidates who qualify physical measurement shall undergo physical endurance test as per the following standards.

i) 01 mile race (to be completed in 7 minutes)

ii) 12 feet Long Jump In three chances
iii) 04 feet High Jump

Note: - Candidates have to qualify in each event of Physical Endurance Test, otherwise they will be eliminated at that stage itself.

#### 7. WRITTEN EXAMINATION (85 marks)

The candidates who qualify in Physical Measurement and Physical Endurance Test will undergo a written test. The paper will be set both in English and Hindi and the candidate will have to answer either in Hindi or English.

**Syllabus:** - The question paper covering a candidate's General Knowledge, Reasoning, Simple Arithmetic and Hindi / English Language.

#### 8. INTERVIEW (10 marks)

The candidates who obtain 40% or more marks in written test will be considered qualified and will be called for an interview /personality test. The interview will be of 10 marks. During the interview the overall personality, aptitude, attitude, general awareness and suitability for the job will be judged by Selection Board.

Apart from this, a maximum of 5 Marks shall be awarded for achievements in Sports and NCC as per scale given below:-

a) NCC 'C' Certificate : 2 marks.

b) NCC 'B' Certificate : 1 mark.

c) Gold medal at National level in sports : 5 marks.

d) Silver medal at National level in sports : 4.5 marks.

e) Bronze medal at National level in sports : 4 marks.

f) Gold medal at State level in sports : 3.5 marks

g) Silver medal at State level in sports : 3 marks.

h) Bronze medal at State level in sports : 2.5 marks.

Candidates should bring all their original certificates of Educational Qualification & achievements in Sports and NCC at the time of interview.

Name of successful candidate based on aggregate of 100 marks will be finalized soon after conclusion of the interview.

#### 9. MEDICAL EXAMINATION

The successful candidate shall be subjected to medical examination as given below:-

- Minimum distant vision should be 6/6 and 6/9 of two eyes without correction i.e. without wearing glasses. The candidate should not have colour blindness.
- (ii) The candidate must not have knock-knee, flat foot, varicose vein or squint eyes, bow legs, inability to flex the fingers properly or any other obvious deformities.
- (iii) The candidate must be in good mental and physical health and free from any physical defects likely to interfere with the efficient performance of police duties.

#### 10. HOW TO APPLY

 (i) Application form would be available at all the Police Stations with effect from 15/09/2014 to 15/10/2014. (ii) Candidate may submit their application form with the self attested copies of certificate of age proof, educational qualification with three passport size photographs (one should be affixed in the space given in the application form and other two should attached along with application form) to Dy. Superintendent of Police (Estt.), Police Head Quarter, Atlanta Point, Port Blair or concerned Police Stations.

Note: - The submission of any forged document shall entail the registration of a criminal case. One candidate can fill up one form only. If any candidate fills up multiple forms, his candidature will be liable to be cancelled.

#### 11. CLOSING DATE

Application form should be deposited to the Dy. Superintendent of Police (HQ), Atlanta Point, Port Blair latest by 1700 hrs on 15/10/2014.

#### 12. INSTRUCTIONS IN GENERAL

- After scrutiny and acceptance of the application forms, each applicant will be issued an Admit card, which will be required at all stages of the recruitment. The Admit card should be collected by the candidate from 01/11/2014 to 15/11/2014 from Recruitment Cell, Police Head Quarter, Atlanta Point, Port Blair
- Benefit of OBC would be given only to those Candidates who belong to the OBC category as notified by the Andaman and Nicobar Administration.
- original documents (Educational qualifications, age proof, sports/NCC, technical qualification and OBC category) will be checked at the time of 'Interview'. The candidates, therefore, should bring these original documents/ certificates only at the time of interview.
- iv) Applications found incomplete in any form are liable to be rejected and no further correspondence will be entertained in this regard. No Admit Card will be issued in case the application is rejected.
- v) Candidates failing at any stage will be eliminated at that stage itself.
