Applications are invited from eligible candidates for the post of Follower Cook in A & N Police Fire Service. The number of post, scale of pay and eligibility conditions are given below:-

1. **NAME OF POST:** - FOLLOWER CONSTABLE COOK
2. **NO. OF VACANCIES:** - (1 vacancy for OBC candidate)
3. **PAY SCALE:** - PB-I ₹ 5200 – 20200 + Grade Pay ₹ 1800/-
4. **ELIGIBILITY CONDITIONS:**

5. **TRADE TEST** (85 marks)

Candidates who qualify in the physical Measurement shall be eligible to appear for Trade Test carrying 85 marks. The Trade shall cover the following aspects of each trade and Selection Board will award the marks on each aspect as indicated below:

i.	Skill of preparing different types of meals/dishes at mess.	50 Marks
ii.	Manner of serving the meal	15 Marks
iii.	Proper cleanliness of utensils	10 Marks
iv.	Cleanliness of the place of the Cooking	10 Marks

6. **INTERVIEW** (15 marks)

The candidate who qualified in the trade test will be subjected to an interview of 15 marks by the Selection Board.

The final list of the selected candidate, in order of merit, will be prepared by adding the scores obtained by candidates in the trade test and interview/personality test, out of 100 marks. The list of selected candidates shall be based on merit and number of vacancies notified/existing.

7. MEDICAL EXAMINATION

The successful candidate shall be subjected to medical examination as given below:-

- (i) Minimum distant vision should be 6/6 and 6/9 of two eyes without correction i.e. without wearing glasses. The candidate should not have colour blindness.
- (ii) The candidate must not have knock-knee, flat foot, varicose vein or squint eyes, bow legs, inability to flex the fingers properly or any other obvious deformities.
- (iii) The candidate must be in good mental and physical health and free from any physical defects likely to interfere with the efficient performance of police duties.

9. HOW TO APPLY

- (i) Application form would be available at all the Police Stations **with effect from 15/09/2014 to 15/10/2014.**
- (ii) Candidate may submit their application form with the self attested copies of certificate of age proof, educational qualification with three passport size photographs (one should be affixed in the space given in the application form and other two should attached along with application form) to **Dy. Superintendent of Police (HQ), Police Head Quarter, Atlanta Point, Port Blair or concerned Police Stations.**

Note: - The submission of any forged document shall entail the registration of a criminal case. **One candidate can fill up one form only.** If any candidate fills up multiple forms, his candidature will be liable to be cancelled.

10. CLOSING DATE

Application form should be deposited to the Dy. Superintendent of Police (HQ), Atlanta Point, Port Blair latest **by 1700 hrs on 15/10/2014.**

11. INSTRUCTIONS IN GENERAL

- i) After scrutiny and acceptance of the application forms, each applicant will be issued an Admit card, which will be required at all stages of the recruitment. **The Admit card should be collected by the candidate from 01/11/2014 to 15/11/2014 from Recruitment Cell, Police Head Quarter, Atlanta Point, Port Blair.**
- ii) Original documents (Educational qualifications, age proof, sports/NCC, OBC Certificate) will be checked at the time of 'Interview'. The candidates, therefore, should bring these original documents/ certificates only at the time of interview.
- iii) Applications found incomplete in any form are liable to be rejected and no further correspondence will be entertained in this regard. No Admit Card will be issued in case the application is rejected.
- iv) Candidates failing at any stage will be eliminated at that stage itself.

- v) The candidates shall prepare for the physical endurance test and participate at their own risk. The A&N Police will not be liable for any damages in the event of any injury or any casualty suffered by a candidate during the test.
- vi) Benefit of OBC would be given only to those candidates who belong to the OBC category as notified by the Andaman and Nicobar Administration.
- vii) The candidates who are not satisfied with the decision of the Recruitment Board concerning their Physical Measurements only may prefer appeal in writing in the prescribed format to the appellate authority on the same day.
- viii) The Physical Measurement, Endurance Test, Written test and Interview will be held at Police Lines, Port Blair. The date and time shall be communicated in due course through local newspapers, All India Radio etc.
- ix) No TA or DA will be paid to the candidates for attending the selection process or Interview.
